In the absence of a proposed agenda I suspect the meeting requested is likely to discuss the memo relating to discharge criteria which is primarily an issue related to the need for the applicant to gain a consent to discharge for the site. We are visiting the DGL site on Thursday and we will discuss with Brian and Stephen then how we will progress this issue. We feel that the issue of discharge criteria is one which is best taken forward by us directly with the Company as it is a Water Order issue primarily. While there is some overlap with the planning process it would be unusual to see detailed discharge parameters within an ES, therefore our bilateral discussions should not delay the planning process or submission of an application.

On the wider planning issue we are more than happy to contribute to the PAD process however adequate notice and an Agenda for the meeting will allow me to identify the appropriate officers to bring to meetings.
