Consultation on Proposed Northern Ireland Non-Quota Shellfish Fisheries Management Plan

The Joint Fisheries Statement (JFS) as amended, as required by the UK Fisheries Act 2020 (the Act), sets out how the UK fisheries authorities will prepare and publish 43 Fisheries Management Plans (FMPs) by 2028.

The Draft Northern Ireland Non-Quota Shellfish FMP is the subject of this consultation. The publication for the final (post consultation) version of this FMP is by end December 2026.

This Draft FMP brings together evidence on the state of the relevant fish stocks (Brown Crab, Velvet Crab, Lobsters, King Scallops and Queen Scallops) and sets out a range of objectives and proposed actions considered necessary to manage these fisheries in an effective and sustainable way.

This consultation is an opportunity for you to help shape and influence fisheries management policy in Northern Ireland for the crab, lobster and scallop fisheries and builds upon previous engagement with a range of stakeholders during the pre-consultation phase. The consultation survey has three parts:
