Environmental Information Regulation 2004

I refer to your request for information received by the Department on 13 April 2026 that sought the following information:

All complaints, reports, records, correspondence and related documentation held by DAERA which were submitted by or on behalf of neighbouring occupiers in respect of property at 86 Clonkeen Road

I can advise that the Department has completed its search and can confirm that it holds some of the information you requested.

The Department has decided not to disclose all of the information you requested as it considers Regulation 12(5)(b) to be engaged. In these instances, the Department is legislatively required to consider the public interest in disclosure. An associated Public Interest Test has been conducted and is attached for your information at **Annex A**.

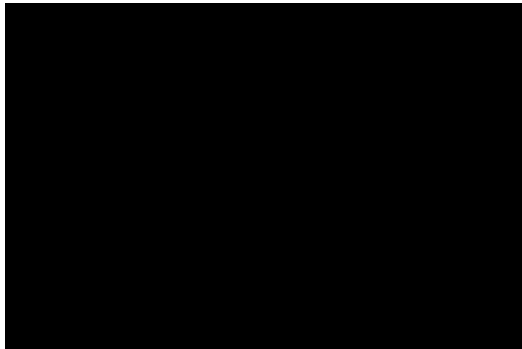
