Environmental Information Regulation 2004

With regard to your request for information received by the Department on 18 May 2026 that sought the following information:

- **Detailed description of the recorded information you want - 'Environmental Impact Assessment', 'Materials Management Plan' or 'Construction Environmental Management Plan' or 'Waste Management Plan' for a former factory development site. Any document submitted which contain all the information on waste soil management, waste soil quality test results and soil disposal arrangements (disposal contractor names and private landowner/s receiving the soil and quantities, and removal dates/schedule). Planning portal ID for construction site in question is R/2006/0424/RM (associated IDs might be LA07/2022/0508/LDP, LA07/2023/2382/CLO PUD and LA07/2026/0373/F).**

If after such an internal review you are still unhappy with the response, you have the right to appeal to the Information Commissioner at Wycliffe House, Water Lane, Wilmslow, CHESHIRE SK9 5AF, who will undertake an independent review of the Department's decision.
