**Environmental Information Regulations 2004**

With regard to your request for information received by the Department on 12<sup>th</sup> June 2026 which sought the following information:

- *All correspondence in relation to the Premises at 379 Middle Road, Islandmagee, Larne; 377 Middle Road, Islandmagee, Larne; and 383 Middle Road, Islandmagee, Larne (together the 'Surrounding Premises') from 1 January 2010 to date.*

I can advise that the Department has completed its search and can confirm that it holds the information you requested which can be disclosed is attached at Annex A.

Some of the information held constitutes personal data of which you are not the data subject. In these instances, the Department is required to consider if disclosure

would breach the first Data Protection Principle, which states that processing must be lawful, fair and transparent.

The Department has considered this element within the test attached at Annex B and has determined that no lawful basis for disclosure under EIR exists. Please bear in mind that any disclosure must be considered in terms of disclosure to the “world at large” and not just to you, the requester. Consequently, third party personal data falling within the scope of this request has been withheld.

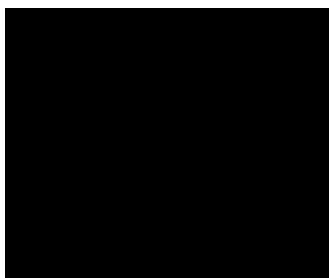

If you are unhappy with the manner in which your request for information has been handled or the decision to release/withhold information, you have the right to request a formal review by the Department.

If after such an internal review you are still unhappy with the response, you have the right to appeal to the Information Commissioner at Wycliffe House, Water Lane, Wilmslow, CHESHIRE, SK9 5AF, who will undertake an independent review of the Department’s decision.
