Please provide the following information relating to earthmoving projects for or on behalf of Valero Energy Ltd during the years 2011 to 2013:

- *Details of all earthmoving projects carried out during 2011, 2012, and 2013.*
- *Copies of any environmental studies or other environmental reports in connection with pipeline, building, or other construction works by or on behalf of Valero, including work carried out by subcontractors during 2011, 2012 and 2013.*
- *Copies of any planning permissions relating to those projects.*
- *Copies of any environmental permits issued for those projects.*
- *Copies of any documents relating to the construction regulations for those projects.*

If after such an internal review you are still unhappy with the response, you have the right to appeal to the Information Commissioner at Wycliffe House, Water Lane, Wilmslow, CHESHIRE SK9 5AF, who will undertake an independent review of the Department's decision.
