Environmental Information Regulations 2004

Regarding your request for information received by the Department on 22 July 2026 which sought the following information:

“Please provide all recorded information held by NIEA, for the period 1 January 2023 to the date of this request, relating to any Multi Agency meetings concerning Re-Gen and Warrenpoint Port as announced by Minister Muir.”

I can advise that the Department has completed its search and can confirm that it holds the information you requested.

The information held which can be disclosed is attached at **Annex 1**

Some of the information held constitutes personal data of which you are not the data subject. In these instances, the Department considers Regulations 12(3) 13(1) of the EIR to be engaged and is required to consider if disclosure would breach the first Data Protection Principle, which states that processing must be lawful, fair and transparent.

The Department has considered this element within the Lawfulness test attached at **Annex 2** and has determined that no lawful basis for disclosure under EIR exists.

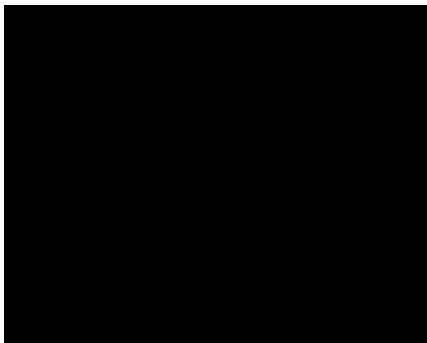
