Environmental Information Regulations 2004

I refer to your request for information received by the Department on 28 July 2026, in which you requested:

- *Copies of any registered waste exemptions, certificates, exemption registrations or equivalent recorded documents which currently or have at any time applied, in relation to Lisbane Site, Tandragee.*

The information held which can be disclosed is attached at **Annex 1**.

Some of the information held constitutes personal data of which you are not the data subject. In these instances, the Department considers Regulations 12(3) 13(1) of the EIR to be engaged and is required to consider if disclosure would breach the first Data Protection Principle, which states that processing must be lawful, fair and transparent.

The Department has considered this element within the Lawfulness test attached at **Annex 2** and has determined that no lawful basis for disclosure under EIR exists.

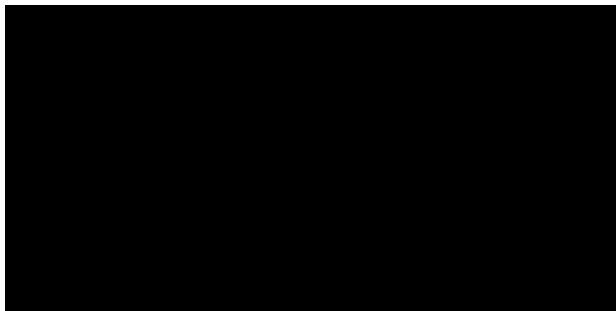
