Thank you for your email received by the Department on 11 August 2026 which sought the following information:

Please could you provide a list of all the DAERA inspections either pre-notified or on the spot for BI 603200 since 2012

I can advise that the Department has completed its search and can confirm that it holds the information you requested. However, The Department has decided not to disclose all of the information as it is being withheld under the following exemption of the Freedom of Information Act:

- Section 40(2) – Third party personal data of which you are not the data subject

In these instances. The Department is required to consider if disclosure would breach the first Data Protection Principle, which states that processing must be lawful, fair and transparent.

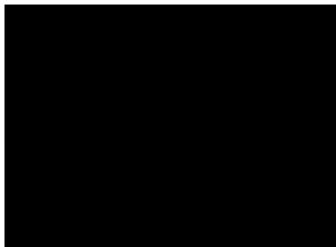

However, the Department would be in a position to reconsider this request if a signed consent from the data subject is supplied.
