Records meeting these criteria have been supplied.

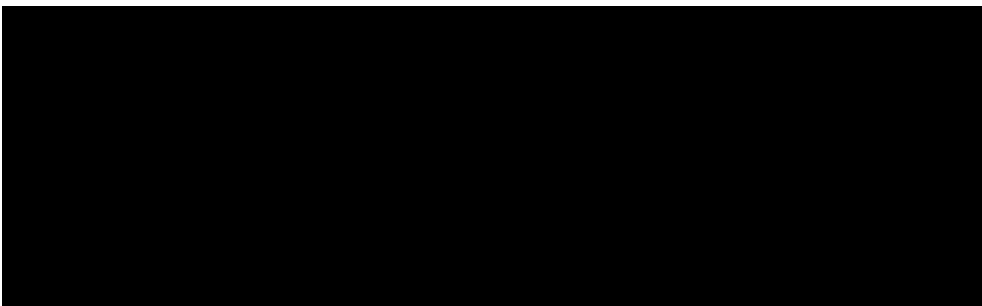
