

Northern Ireland Milk Prices and Production

The latest national statistics produced by DAERA on Northern Ireland milk price and production were released on 3rd September 2026, according to the arrangements approved by the UK Statistics Authority.

This monthly notice will be updated in October 2026.

Key Points

This release shows the latest monthly information on the average Northern Ireland farm-gate milk prices and the volume of raw milk produced.

- In June 2026 the Northern Ireland average farm-gate price of milk (including retrospective bonuses) was 35.90 pence per litre, 7.38 pence per litre lower than June 2025.
- The weighted average farm-gate price of milk during January to June 2026 was 34.23 pence per litre, 10.74 pence per litre lower than the same period in 2025.
- In June 2026 the volume of raw milk produced from Northern Ireland farms was 256.08 million litres, 0.55 per cent higher than June 2025.
- In the Period from January to June 2026, the volume of raw milk produced was 1547.49 million litres, 2.93 per cent higher than the same period in 2025.

Section 1: Northern Ireland farm-gate milk price (pence per litre)

Table 1 shows average Northern Ireland farm-gate prices calculated from monthly surveys of milk purchasers in Northern Ireland.

Average producer prices for raw milk include all retrospective bonuses paid to date and are subject to further minor adjustments to take account of any future retrospective payments. Transport charges have been deducted, but there has been no deduction in respect of any super-levy liabilities.

Section 3: Methodology, Notes and Revisions Policy

User Statement

The information in this publication is used by the Northern Ireland government as evidence for assessing market conditions and evaluating agricultural policy. The milk producer price series is used to estimate the milk component of the Aggregate Agricultural Account for Northern Ireland. The data is used by Defra in the UK Agricultural Account and to provide a UK milk price. The Rural Payment Agency ceased the collection of information on volume, butterfat or protein content of milk delivered to dairies on the 31st March 2015 when milk quota regulations were ended. Other users include the food and farming industry, academia and the general public. Survey Methodology

DAERA runs a compulsory monthly survey of registered milk purchasers in Northern Ireland to collect information on the volume and value of milk purchased, transport costs and the value of bonuses paid. Similar surveys are run by Defra to collect data from dairies in England and Wales, while the Rural & Environment Science and Analytical Service (RESAS) cover dairies in Scotland.

Milk Price Statistics

The average prices are based on monthly returns made to DAERA by milk purchasers operating in NI who purchase raw milk from farms. The prices include retrospective bonuses paid to date. Transport charges are deducted but no deduction is made in respect of superlevy liabilities. They are calculated using the weighted average of returns received.

Once statistics have been accredited it is a statutory requirement that the Code of Practice shall be observed regarding them. These accredited official statistics were independently reviewed by OSR in 2011. Revisions policy

Figures in the publication are provisional and subject to revision. We will provide information about any revisions we make to previously published information in the publication.

Revisions could occur for various reasons, including:

- a. if we have not received survey data from respondents in time we make an estimate based on their previous returns. These estimates are then replaced with actual figures.
- b. survey respondents occasionally supply amended figures for previous periods.
- c. payment of retrospective bonuses which affect the net producer price.
- d. additional or new firms are identified and included in the survey.

Please note that the Northern Ireland farm-gate price of milk figures has been revised slightly from January 2025 - May 2026 due to updated data becoming available.
