CONSULTATION ON AMENDMENTS TO THE EGGS AND CHICKS REGULATIONS (NORTHERN IRELAND) 2010

I am writing to invite your comments on proposed amendments to the Eggs and Chicks Regulations (Northern Ireland) 2010. As the legislation that is being amended relates to food, this consultation is being carried out as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council, laying down the general principles and requirements of food law.

The amendments make minor wording changes in order to ensure that the legislation will remain fully operable after the UK's Exit from the EU.

Background

The European Union (Withdrawal) Act 2018 (the 2018 Act) will repeal the European Communities Act 1972 (the ECA) on the day the UK leaves the European Union (EU). The 2018 Act also converts EU law as it stands at the moment of exit, into UK domestic law and preserves UK laws made under the ECA to implement EU obligations.

Powers in the 2018 Act enable amendments to be made to EU Law to ensure that such legislation can work properly in the context of the UK no longer being a member of the EU. The 2018 Act also allows for amendments to be made to domestic legislation which implements and enforces EU obligations in Northern Ireland, in order to ensure it is operable after EU Exit. One such piece of legislation is the Eggs and Chicks Regulations (Northern Ireland) 2010.

Detail

The proposed amendments do not introduce new policy and simply seek to ensure that the legislation will continue to operate in the same way on Exit Day as it does currently.

The amendments remove certain provisions relating to eggs in shell for consumption that it is currently an offence to contravene, on the basis that the provisions relate specifically to the UK being a Member State. The instrument also removes references to Article 4 of Council Directive 1999/74/EC, and replaces this with a reference to the Welfare of Farmed Animals Regulations (Northern Ireland) 2012, as the Council Directive is already fully transposed into that Northern Ireland domestic legislation.
