

## Freedom of Information Act 2000

I refer to your request for information received by the Department on 6 May 2020 that sought the following information in relation to the Horse Racing Fund:

- 1. How much was collected from bookmakers and other sources over the last 5 years?
- 2. How that money was spent and specifically how much was paid to Downpatrick and Down Royal Race Tracks over the same 5 year period?
- 3. What was the purpose of those payments?
- 4. Whether the payments to Down Royal have altered since the operation of the track changed in January 2019 from Down Royal Corporation of Horse Breeders to Dublinbased property developer Mike Roden?
- 5. Whether the Department has checked whether this change of circumstances at Down Royal has implications for EU state aid and competition law?
- 6. Please direct me to whatever legislation and other rules are relevant to the administration of the Fund and the donations to each race track.

I can advise that the Department has completed its search and can confirm that it holds the information you requested which is below.

3. The purpose of all payments made to Downpatrick and Down Royal racecourses over the past five years has been to meet the legitimate claims that they made to the Horse Racing Fund under the terms of The Horse Racing (Northern Ireland) Order 1990.

4. No payments have been made by the Department to the new operators at Down Royal Racecourse (Down Royal Park Racecourse Limited) since they replaced the previous operators on 1<sup>st</sup> January 2019, as they are not a named beneficiary of the Horse Racing (Northern Ireland) Order 1990.

5. The Department has considered the operation of the Horse Racing Fund in light of EU Rules on State Aid. An application was submitted to the European Commission on 31<sup>st</sup> December 2019 seeking to obtain a Commission decision in respect of the operation of the Horse Racing Fund.

6. The Horse Racing Fund is administered under the terms of The Horse Racing (Northern Ireland) Order 1990 and the Horse Racing (Charges on Bookmakers) Order (Northern Ireland) 2010.
