#### **Robert Huey Chief Veterinary Officer for Northern Ireland**



- Under the Northern Ireland (NI) Protocol, the UK Government agreed that, following EU exit, NI would continue to align with EU rules for movement of Sanitary and Phytosanitary (SPS) eligible goods into NI.
- These rules are laid down in a key piece of EU legislation known as the Official Controls Regulation (OCR) (Regulation (EU) No.2017/625).



The OCR requires that, in order to protect public health and the health of animals and plants, official controls must be carried out at all points of entry into the common regulatory zone.

They form part of the EU's biosecurity programme, to allow movement of goods and protection of human health, while avoiding incursion of animal, plant or human diseases.



Under OCR, DAERA and the FSA in NI are the Competent Authorities responsible for Sanitary and Phytosanitary (SPS) controls on certain goods coming into Northern Ireland, including:

≻Live animals

- Products of Animal origin
- Plants and plant products
- >Wood packaging material (must be ISPM 15 compliant)
- DAERA and Local Authorities are responsible for carrying out the necessary checks



## What does this mean for agri-food goods arriving into NI from GB?

From 1 January, there will be additional steps you need to follow for moving goods, including:

- 1. Registering and pre-notifying arrival of a consignment
- 2. Have Official document from competent authority in GB
- 3. Making sure the consignment enters via a designated Point of Entry
- 4. Preparing for potential sanitary and phytosanitary inspections on arrival at Point of Entry inspection facilities (possibility of delays)



## **Certification required to accompany goods**

Official documentation is required before your goods can leave GB:

- EHCs will be required for movements of animal products and live animals.
- >Official certificate signed by the operator for retail goods
- Phytosanitary certificates will be required for movements of plants and plant products
- Catch certificates will be required for movement of fish and some fish product
- Official certificates/certificates of conformance will be required for high risk foods and feed not of animal origin
- These certificates are verified by authorised officials before leaving GB



## Registering and pre-notifying arrival of consignment

The operator will now be required to pre-notify DAERA of the arrival of your consignment

This requires you to:

- ➢Register on TRACES.NT;
- Pre-notify arrival of your consignment on TRACES.NT by completing electronic documentation;
- TRACES details & training on EU Exit part of DAERA website under useful links.



## Ensure your consignment enters via a Point of Entry

- Points of Entry are an inspection facility designated and approved in line with EU legislation for carrying out checks on agri-food goods
- You need to plan your journey to ensure your consignment arrives at the correct Point of Entry for your consignment
- DAERA are working with EU to designate the following as Points of Entry in Northern Ireland:
  - Belfast Port
  - Larne Port
  - Warrenpoint Harbour
    - Foyle Harbour

### Sanitary and Phytosanitary Inspections at Points of entry



#### Documentary checks

- >These are specific to the exported good
- ➤Carried out remotely prior to sailing

#### Identity checks

- This is to confirm that the goods contained within the Document describe those goods carried
- Most of these will be carried out through the checking of an Official Seal carried out in GB ports prior to sailing

#### Physical checks

These are carried out at a frequency described in EU legislation at facilities provided at the Points of Entry



## Live animals and goods categorised as high risk

➢Full compliance from 1<sup>st</sup> January

➢Non compliant goods

- Re-exported
- Destroyed
- Subjected to a treatment to render them safe



#### **Retail Goods**

- They are packaged for end consumers and bear a label reading 'These products from the United Kingdom may not be marketed outside Northern Ireland'.
- They are destined solely for sale to end consumers in supermarkets located in Northern Ireland, and they cannot be sold to other operators of the food chain,
- They are accompanied by a simplified official certificate globally stating the products meet all the import requirements of EU legislation,
- They enter Northern Ireland through a designated place as defined in point (38) of Article 3 of Regulation (EU) 20178/625 of the European Parliament and of the Council, where they are submitted to a systematic documentary check and to a risk-based identity check on the selection of terms in the means of transport, and
- They are monitored through a channelling procedure applicable from the designated place as defined in point (38) of Article 3 of Regulation (EU) 2017.625 of the European Parliament and the Council of the destination supermarket in Northern Ireland.



#### What exporter of retail goods needs to do for day 1

Confirm traceability and eligibility of retail goods

Establish systems that will allow signing of commercial certificate, application and recording of commercial seal

- ➢ Prepare TRACES NT for pre-notification
- Prepare for labelling of products
- Prepare for possible delays



#### **Compliance Protocol: retail goods**

➢ Day 1-7 - preparation time, advice

### Day 7 - pre-notification on TRACES NT, Commercial cert, seal applied

➤Day 14 - labelling in place



### **Rules for chilled mince & preps**

- The meat products enter Northern Ireland through a designated place a defined in point (38) of Article 3 of Regulation (EU) 2017/625 of the European Parliament and of the Council and they are subject to channelling procedure applicable from the designated place to the destination supermarket in Northern Ireland;
- They are sold exclusively to end consumers in supermarkets located in Northern Ireland, and they are not to be sold to other operators of the food chain;
- They are accompanied by official certificates issued by the UK competent authorities (based on similar models already existing for fresh meat, minced meat and meat preparations) and
- They are packed for end consumers, and they bear a label reading 'These products from the United Kingdom may not be sold outside Northern Ireland'.



## What exporter needs to do for prohibited or restricted goods from day 1

Confirm traceability and eligibility of retail goods

- Establish systems that will allow signing of official certificate, application and recording of official seal
- ➢ Prepare TRACES NT for pre-notification
- Prepare for labelling of products
- Prepare for possible delays



### **Compliance Protocol: Mince and preps**

➢ Day 1-7 - preparation time, advice

#### Day 7 - pre-notification on TRACES NT, Official cert, seal applied

➤Day 14 - labelling in place



### Non compliance

First week - a non-compliance note will be issued

Day 7 - no document or seal, non-compliant to travel to NI, return to exporter. If reaches NI, re-export or destruction.

Day14 - labels not compliant at physical check, re-export or destruction.



#### What steps can you take to prepare now?

Familiarise yourself with certification issued by competent authorities in Great Britain

>Get to know your regulations including goods on the prohibited lists

≻Register on TRACES.NT

➢Follow HMRC guidelines and obtain XI EORI number

>Ensure you are registered as an official operator with DAERA (PH)

## **Northern Ireland Points of Entry**

#### >What are they?

✓ Facilities approved for the inspection of agri-food goods entering the EU

#### >Where will they be located?

✓DAERA are working with EU to designate Belfast Port, Larne Port, Warrenpoint Harbour and Foyle Harbour as points of entry

✓Belfast International Airport also currently designated

#### >What will take place at a Point of Entry?

✓ Sanitary and Phytosanitary inspections of certain goods that are accepted at a specific point of entry



## **Contingency Arrangements**


Plans for new infrastructure at all four portal Points of Entry

- >Interim measures for physical checks in place from
  - 1 January 2021
    - Belfast three separate sites throughout the harbour estate
    - Larne current buildings and modular builds
    - Warrenpoint and Foyle temporary facilities for product



#### Goods Arriving in Northern Ireland Notification of inspection

A facility to check if your consignment has been selected for a check will be available online

>This should be checked before disembarkation.

- If you are not selected for an inspection, you can leave the port on disembarkation
- If selected for inspection you must follow directions to the inspection facility



#### Instructions for consignments arriving at Points of Entry

- This instruction applies to all consignments that require prenotification on TRACES NT instructions on DAERA website
- Information identifying the vehicle/trailer or container used for transporting goods from GB to NI must now be included on the CHED part 1 on TRACES NT.
- Different requirements apply to vehicles and unaccompanied goods. Information must be unique to the mode of transport and can be a vehicle registration number, trailer number or container number.
- In addition where a seal has been put in place the seal number must be recorded.
- The Goods Movement Reference (GMR) from your customs declaration should also be supplied.



### Instructions for consignments arriving at Points of Entry

Consider business model to reduce the chance of delays

- Group consignments subject to higher levels of inspection
- Place goods that might be checked closer to the door if possible
- Operators' responsibility to present goods for inspection (including shunting containers to inspection sites)



#### **Key Messages**

Group consignments subject to higher levels of inspection

For goods that require checks, advise these are placed beside the door of the container etc., if possible

From the 1<sup>st</sup> January information identifying the vehicle/trailer or container used for transporting goods from GB to NI must now be included on the CHED part 1

### **Action for Businesses**





#### Register for the Trader Support Service

The Trader Support Service will provide free training and support for businesses for customs processes that will arise for goods moving between GB and NI.

The Trader Support Service can provide support in registering for an EORI number, understanding Incoterms and in making declarations for goods moving from GB to NI.

Even if you are not sure whether you will buy from/sell to GB in the net year, it is worth registering just in case.



#### Get an EORI Number

You will need both a GB EORI number and an XI EORI number if you buy from GB. If you do not already have a GB EORI number, you can apply for both a GB EORI number and an XI number at the same time. There is no risk to having an EORI number if you do not use it.

If you already have a GB EORI number and register with TSS before 14 December, HMRC will automatically issue you with an XI EORI number. If you do not automatically get one, HMRC will have a process to apply for one.



#### Find out the Commodity Code

If you buy from/sell to GB, you will need to know the commodity codes for the goods you purchase and sell.

For goods you purchase, you should speak to your supplier, they may be able to tell you the code. You can also check the code using the Trade Tariff.

You should check the tariffs applicable under the EU Common External Tariffs and UK Global Tariff (UKGT).



#### Speak to your Haulier

If you move goods to or from GB, ask your haulier what information they will need from you.

Find out whether your goods routinely move through Dublin port, as processes will be different for goods that travel via Ireland.



### Speak to Suppliers

Ask your suppliers what preparation they have made for Brexit. If your supplier is in GB, ask whether the terms of trade (responsibilities of buyers and sellers) through Incoterms will remain the same and who will be accountable for declaring goods to customs.

You should suggest that your supplier registers for the Trader Support Service.



### Check Regulations

- Check whether your goods must meet EU standards and how these goods are approved for the EU market at the moment.
- Ask your supplier whether they will continue to ensure the products meet the requirements for the EU market.
- If your goods are currently assessed by a third party conformity assessment body, you may need to take action if you want to continue to use the CE marking.
- If you use, sell or manufacture chemicals, you will need to check your regulatory responsibilities with respect to that chemical in the NI/EU market.



#### Consider your Data

Prepare for a scenario where the UK has not been granted an adequacy decision by the EU.

Make a list of all the data flows into and out of your business. If you receive personal data from the EU, you may need to take action.

The Information Commissioner's Office has information on possible steps you will need to take.
