As the Future Agricultural Policy Decisions will affect virtually all farmers in Northern Ireland it will therefore affect the people in rural areas. The future agricultural support policies and schemes will replace existing CAP Schemes and are designed to deliver four main outcomes: an industry which pursues increased agricultural productivity as a means to sustained profitability, is environmentally sustainable, displays improved resilience to external shocks and which operates an effective functioning supply chain. The aim is to ensure that Northern Ireland takes full advantage of the opportunity to develop a sustainable agricultural industry in which farmers are supported on an equitable basis to make best use of the assets at their disposal, and to invest in all forms of capital — physical, environmental and human.

Through the **Northern Ireland Future Agricultural Policy Framework** stakeholder engagement carried out in 2018 and the Consultation on Future Agricultural Policy 2021, DAERA identified the following social and economic needs of people in rural areas:

There could be a disproportionate effect on people in rural areas if farmers are not viewed as equal partners in the supply chain.

There is a need to be cognisant of different types of farms/farmers/landscape (e.g. hill farmers and lowland farmers; small farms and large farms), different communities (e.g. farmers in border communities and farmers in non-border communities) and different types of producers (e.g. horticulture and agriculture).

People in rural areas have issues around rural poverty, mental and physical health, inequalities in health and social inclusion

Key Rural Issues Northern Ireland 2020 report highlighted the contribution of agriculture to rural business with 41% of rural businesses being in the agriculture, forestry and fishing sectors, Poverty levels in households in rural areas which are more than an hour's journey from Belfast are much higher than those of rural areas closer to the city

The average age of farmers in Northern Ireland was 59 years. Only 8% of farmers were aged under 40 years, and more than a third (36%) were aged 65 years or older (49% over sixty).

Almost a third (30%) of farmers stated that they had a long-term illness or disability which limited their daily activities, with the incidence of disability inversely related to farm size.

The social and economic needs of people in rural areas identified in the **Northern Ireland Future Agricultural Policy Framework** stakeholder engagement carried out in 2018 and the Consultation on Future Agricultural Policy Proposals 2021 have been considered. The Future Agricultural Policy Decisions and associated policy development should take into consideration the responses received; namely: i) the effect on people in rural areas if farmers are not viewed as equal partners in the supply chain; ii) different types of farms/farmers/landscape (e.g. hill farmers and lowland farmers; small farms and large farms), different communities (e.g. farmers in border communities and farmers in non-border communities) and different types of producers (e.g. horticulture and agriculture); iii) broadband quality and public transport and maintenance and road networks and iv) rural poverty, mental and physical health, inequalities in health and social inclusion.

The Future Agricultural Policy Decisions have been made with the expectation of the continued application of Article 10.2 of the Ireland/Northern Ireland Protocol that sets the maximum overall level of agricultural support at £382.2 million per annum and the minimum percentage of this that needs to comply with the WTO Green Box classification at 83%. Subsidies granted in accordance with Article 10 of the Protocol (including future farm support payments in Northern Ireland) will not be subject to the UK Subsidy Control Regime unless the Northern Ireland Protocol Bill is enacted

Future support must also take into account the following principles:

- It must not conflict with World Trade Organization obligations; and
- It should not give rise to unacceptable market distortions within the UK.
