#### 1. Welcome

Seamus Hughes welcomed everyone to the second meeting of the Implementation Group to take forward the Strategy for the Sustainability of the Honey Bee.

# 2. Role, membership and work timetable of sub groups

Seamus Hughes thanked INIB and UBKA for providing nominations for the sub groups. DARD and AFBI representatives would be agreed today. It was confirmed that sub groups are to be kept small with additional people being co-opted on as necessary.

It was suggested that INIB and UBKA could chair two sub groups each and rotate on an annual basis if preferred.

An alternative proposal tabled was that each sub group should elect Chairs based on the best person for the role, regardless of which association they represented.

It was agreed that Chairs did not necessarily have to be the most experienced or expert beekeepers; rather Chairs should be the best people to guide the activity of the sub groups.

Following discussion it was agreed that sub groups would discuss/agree Chairs at their first meetings. If agreement could not be reached on the issue it would be brought back to the Implementation Group to determine, but the general view was that this is unlikely to be necessary.

It was agreed that Paula Magill would set up user groups for e-mails for each sub group.

#### 3. Communications / NI Direct

Seamus Hughes explained that information about bees currently on the NI Direct website has come from a number of sources.

While NI Direct is a Government website it was felt that there would be merit in beekeepers putting forward information, aimed at beekeepers and the general public, that they would like included on NI Direct.

It was agreed that the communications sub group could be tasked with considering the bee content pages on NI Direct with a view to updating and suggesting additional material.

# 4. Next steps

It was agreed that it was key to get the first meetings of the sub groups set up, Chairs determined and initial thoughts about issues established.

It was agreed that the outcomes of the first meetings of the sub groups would be discussed at the next Implementation Group meeting in August 2011.

It was confirmed that Chairs of sub groups should put forward proposals to the Implements Group for consideration / approval before moving forward. It was also stressed that it was important to set out to each sub group the overall structure and reporting structures.
