INSTRUCTIONS

- 1. Sheep move from flocks of origin on a self written SG2 movement document.
- 2. The Exporter applies for export paperwork to their AVI using the **TRACES** Application Form.
- **3.** The AVI requests a Veterinary Service Support Certificate **GB 10 B&P VSSPT** for the Assembly Centre through eSAVI.
- DARD VO/DVO approves a Veterinary Service support certificate GB 10 B&P VSSPT (EAC) through the Export Filter Queue on APHIS as per the notes for guidance GB B&P S/G NFG VSSPT (EAC).
- **5.** EAC operator scans sheep into the EAC (CPR EACs). For non CPR EACs the AVI processes the sheep in through e-SAVI.
- 6. The Exporter completes the Owner's/Exporter's Declaration GB 10 B&P OD (available from AVI through eSAVI) referring to the relevant notes for guidance GB-B&P-S/G-ONFG (EAC).

Both documents are available from the DARD website at <u>www.dardni.gov.uk</u>. However, if this is not possible, they may be obtained from the local DARD Office, on request.

- 7. The AVI generates an Export Health Certificate GB 10 B&P EHC and the Sheep Movement Licence OVNLIC through eSAVI.
- 8. AVIs should obtain their Notes for Guidance GB B&P S/G NFG AVI (EAC) and Checklist GB B&P S/G CKL AVI (EAC), relevant to the type of trade from the DARD website at <u>www.dardni.gov.uk</u>. However, if this is not possible, they may be obtained from the local DARD Office, on request.
- 9. The AVI completes the Export Health Certificate using for guidance:
