# Water Pollution Incidents Since 01<sup>st</sup> June 2013

- 59 Incidents reported
- 32 Incidents confirmed
- 3 High Severity
- 1 Medium Severity
- 28 Low Severity



## Low Severity Incidents June – Oct 2013

- 8 Agricultural (deliberate dumping, equipment failure, negligence, poor working practice, weather)
- 7 Sewage (network foul blockages & equipment failure)
- 7 Industrial (accident/emergency, inadequate equipment, equipment failure, weather, deliberate dumping)
- 6 Other (oil, algal booms, dumping)






Fish kill at Moorlough, Lisnaskea July 10th 2013






